## Privacy Policy

**We will process your data in accordance with the The General Data Protection Regulation (GDPR) 2018. The purpose of the privacy policy is to inform you as a user of the site about what information we collect when you visit the site, how we use the information, whether the information is disclosed and the ways in which we protect users' privacy.**

We want you to feel secure when visiting the site. We are committed to respecting your privacy. Below we give an overview of how we do that.

### **Information we collect when you visit [www.a6physio.co.uk](http://www.a6physio.co.uk)**

We collect information indirectly and directly.

When you access [www.a6physio.co.uk](http://www.a6physio.co.uk), we use technology to collect information indirectly, such as your internet address, which is then kept in our internet access logs.

We collect information directly from you in a number of ways. One way is by using cookies. Cookies are small files of information that save and retrieve information about your visit to our site, such as how you entered our site, how you navigated through the site and what information was of interest to you. In addition to this, if you customise the homepage, we will store the information you give us in a cookie.

The cookies we use identify you merely as a number. (If you are uncomfortable about the use of cookies, you can disable cookies on your computer by changing the settings in the preferences or options menu in your internet browser.)

### **How do we use this information?**

We analyse it to see what is most effective about our site, to help us identify ways to improve it, and to make it more effective. We may also use data for other purposes, which we would describe to you at the point we collect the information.

### **Will we disclose your information to or share it with other organisations?**

As a private organisation, we do not share data with other organisations unless the law permits us to do so. We do not sell individual information. We will share it only with our authorised Data Processors, who must act at all times on our instructions as the Data Controller under the The General Data Protection Regulation (GDPR) 2018. Before you submit any information, we will notify you as to why we are asking for specific information and it is up to you whether you provide it.

### **We may give you access to your information**

You are entitled to know whether we hold information about you and, if we do, to have access to that information and require it to be corrected if it is inaccurate. You can do this by contacting us.

**Your data is kept under secure conditions**

We take appropriate steps to maintain the security of your data on our website. The open nature of the internet means that data may flow over networks without security measures and may be accessed and used by people other than those for whom the data is intended. Our intention is that this should not happen and we take measures to ensure that it does not.
